Indicator 1: Children in Single Parent Families

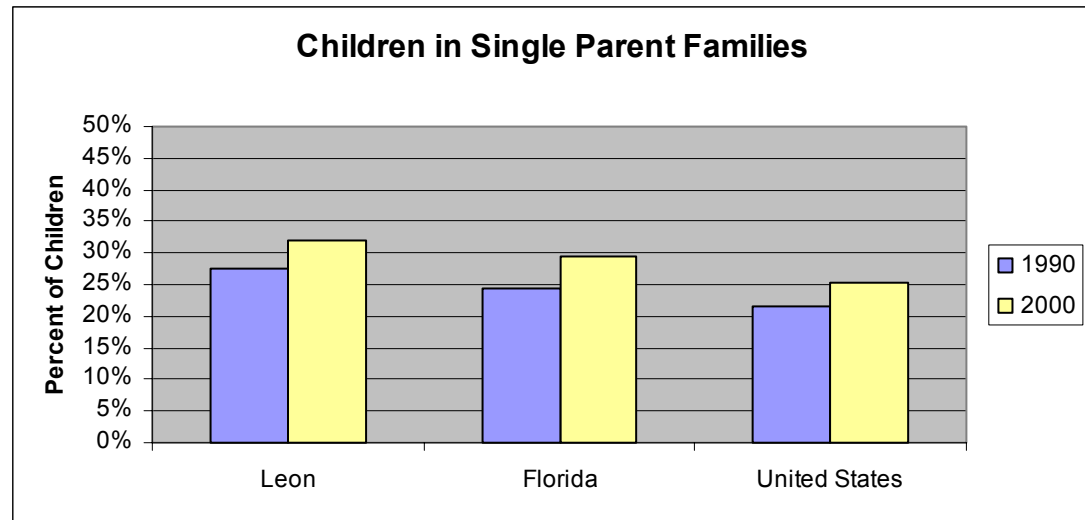
Indicator:

Percentage of children, under age 18, who live in single parent families (rather than in married couple families).

Analysis:

In 2000, nearly one in three children in Leon County lived in a single parent family – a higher percentage than in Florida or the United States.

The percent of children living in single parent families has increased over the past decade in Leon County, the state and the nation. Most of these families are headed by a single female.

Indicator 2: Births to Unwed Mothers

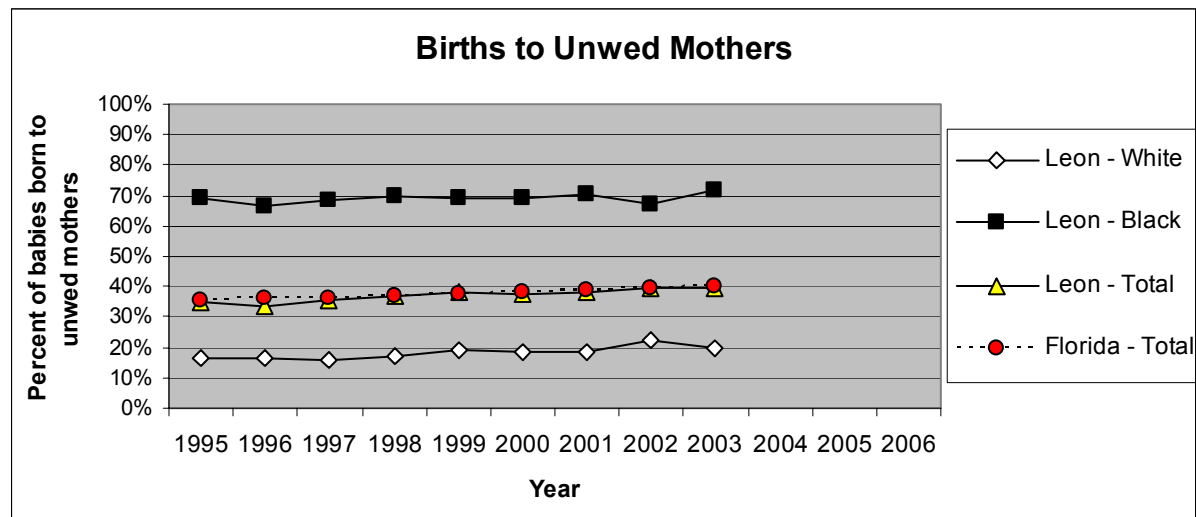
Indicator:
Percent of births to unwed mothers, by race.

Analysis:
The percentage of babies born to unwed mothers continues to slowly increase in Leon County – with a sharp increase in 2003 for Blacks. Black children are nearly 4 times as likely to be born to unwed mothers as White children in Leon County.

Overall, Leon County continues to mirror the state as a whole on this indicator. Two in five babies of all races are born to unwed mothers in Florida.

Indicator 3: Births to Teen Mothers

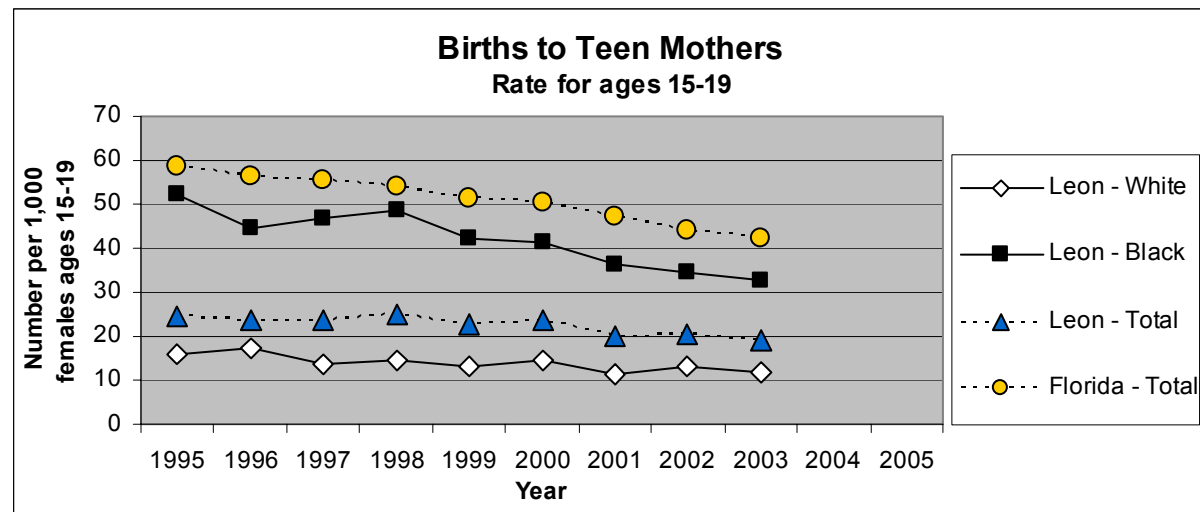
Indicator:

Number of teenage mothers, ages 15-19, who gave birth per 1,000 teenage girls ages 15-19.

Analysis:

The rate of births to teenage mothers has been declining in Leon County and in Florida. A significant racial disparity exists but the gap is closing, primarily because of the decline in the rate of births to black teenagers.

The rate of births to teens in Leon County for all races is less than half the state rate.

Indicator 4: Children in Foster Care

Indicator:

Number of children under age 18 who are in foster care or residential group care under the custody of the Florida Department of Children and Families (DCF).

Analysis:

In this region of Florida, the number of children in foster care and residential group care peaked in 1998 and has remained relatively level since 2001. In Florida, the number decreased considerably in 2004 but not in Leon County.

District 2 includes 14 counties in north Florida, including Leon.

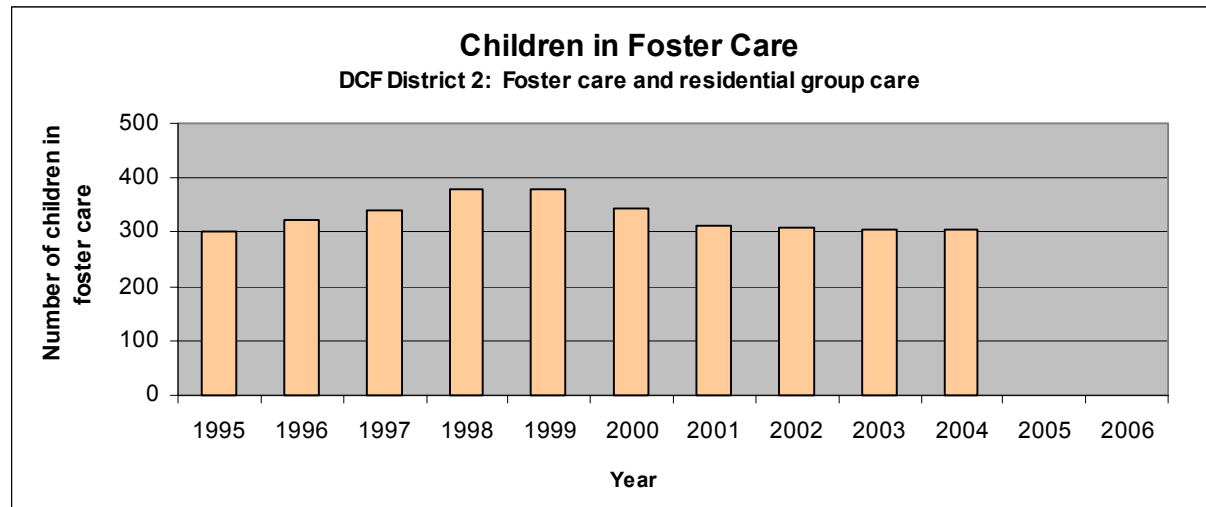

Indicator 5: Child Abuse and Neglect

Indicator:

Number of child abuse and neglect victims (per 100,000 children under age 18) whose maltreatment was verified or found to have some evidence of occurrence.

Analysis:

The rate of child abuse and neglect in Leon County continued to decline in 2003-04 after a period of elevated rates in 1999-00 and 2000-01.

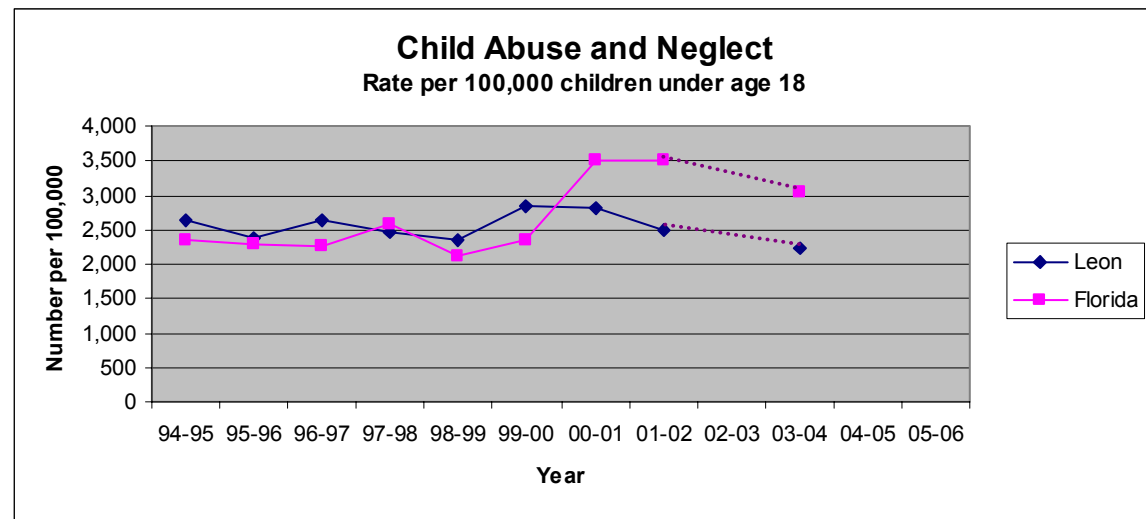
Leon County's rate was the same or higher than the statewide rate until 2000-01, when it dropped below the state rate. The unusually high rates for Florida in 2000-01 and 2001-02 most likely reflect a statewide initiative to investigate backlogged cases.

Note: The same child may be counted more than once if involved in more than one incident. An unusually high rate in a single year is most likely due to a reduction of backlog (closure of a high number of reports from prior years), while an unusually low rate may be due to growth in backlog. 2002-2003 data are incomplete due to a new reporting system that was phased in across the state.

Indicator 6: Child Care Affordability

Indicator:

Cost of child care in Leon County as a percentage of family income.

Analysis:

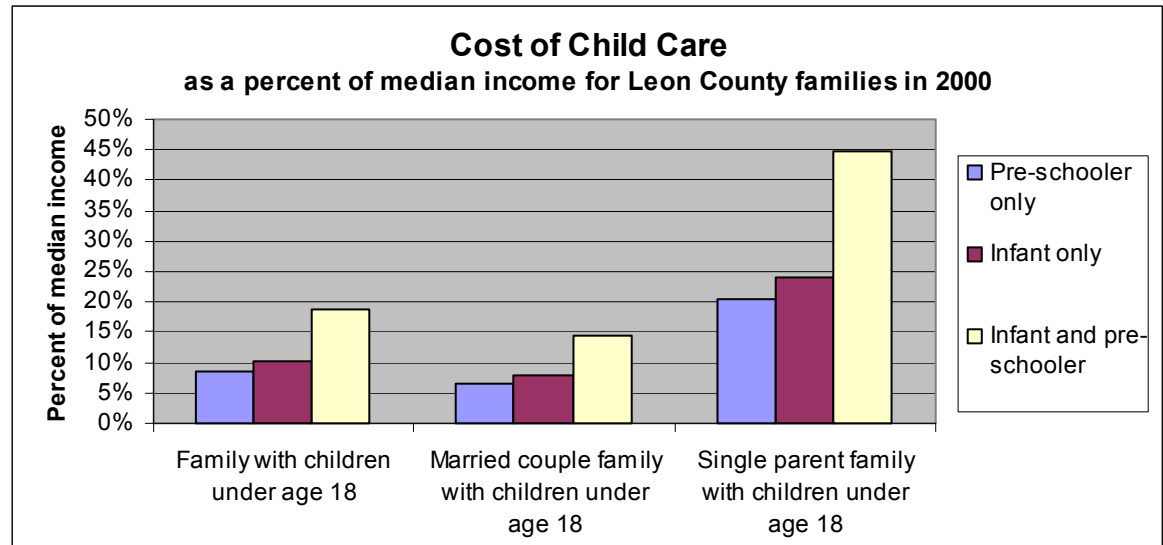
The average family with children pays a substantial portion of their income on child care – especially if they have more than one child in need of care. Single parent families are at a particular disadvantage because their median income is less than one-third of the income of married couples with children.

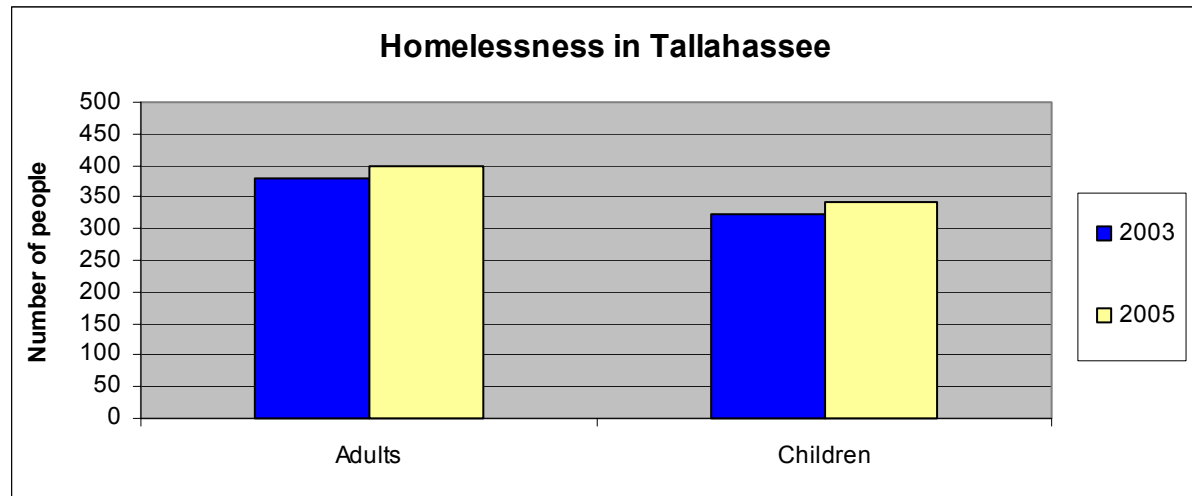

Indicator 7: Homelessness

Indicator:
Number of homeless people in Tallahassee.

Analysis:
In 2005, a total of 739 people in Tallahassee reported having no regular place to stay or expected to be forced to leave their home within the next week without another place to go. Almost half (46%) of the city's homeless in both 2003 and 2005 were children, ages 0-18.
